

Terms and Conditions

Chelsea Flower Show Notcutts Social Competition

- These terms and conditions apply to the online action 'Win a pair of tickets to this year's RHS Chelsea Flower Show'. The competition runs from 29 APRIL 2018 until midnight 7 MAY 2018
- **The Promoter** is Notcutts Ltd registered in England and Wales No. 393104 with registered office at Cumberland Street, Woodbridge, Suffolk, IP12 4AF, United-Kingdom.
- The promotion is open to residents of the UK and Ireland aged 18 or over who are active members of the Notcutts loyalty scheme, excluding employees and their immediate families of the Promoter, its agents or anyone professionally connected with the promotion.
- By entering the promotion, entrants confirm that they have read and agree to be bound by these terms & conditions and by the decisions of the Promoter, which are final in all matters relating to the promotion. Failure to do so will result in the forfeiture of the prize. No correspondence will be entered into.

To take part and be eligible for a prize, the entrant must **share an image of your favorite plant or spot in your garden and tell us why you would like to go to the RHS Chelsea Flower Show 2019** on Notcutts social media pages, the winner will be contacted via the post. Multiple entries will be accepted. Email addresses are not a requirement of entry.
- Contact numbers where supplied will only be used as the contact details to advise a participant that they have won a prize.
- The address confirmed via contact after the winner is notified will be used to send any prizes so please make sure this is correct. Competitions are only open to residents of the United Kingdom and you are not eligible if you are resident outside of the United Kingdom.
- The data from participants will be used exclusively for the Promoter for email marketing purposes. The Promoter only sends email messages to people who have opted-in. Users always have the opportunity to opt-out or change preferences via a link in the footer of all marketing email messages. Some communications (e.g. important account notifications and billing information) are considered transactional and are necessary for all customers.
- By opting to the Promoter's terms and conditions, the participants signal their complete acceptance and full understanding of these Terms and Conditions and agree:

- The prizes are non-refundable and non-transferable, no cash alternative is available. Due to nature of the prize the winner will be a named recipient on the tickets and this cannot be changed or transferred. Prizes must be taken as stated and no compensation will be payable

if a winner is unable to use the prize as stated. The Promoter reserves the right to provide alternative prizes of equal value if, due to circumstances beyond its reasonable control, the stated prizes are no longer available.
